**Range Rates**

*Short Bays (Bay 1-5, East 100):*

- \$30.00/hour for each increment of 5 shooters or any part thereof  
OR  \$100.00/half day (4 hours) for each increment of 5 shooters or any part thereof  
OR  \$200.00/full day (8 hours) for each increment of 5 shooters or any part thereof

*Long Range Platforms (West 1-4, East Platform):*

- \$45.00/hour for each increment of 5 shooters or any part thereof  
OR  \$150.00/half day (4 hours) for each increment of 5 shooters or any part thereof  
OR  \$300.00/full day (8 hours) for each increment of 5 shooters or any part thereof

*Shoot House:*

- \$250.00/half day (4 hours) for up to 15 participants  
OR  \$500.00/full day (8 hours) for up to 15 participants

*Fee for Multi-Day Use: (For one or more firing positions):* For large events or by annual contract:

Fee determined on case by case basis by MANAGER based on number of shooters, number of shooting positions, duration of use, scope of use and weekday vs. weekend.
